Cranbrook Poverty Reduction Committee: Developed report in collaboration with Kerri Wall and Darcy Victor to Ministry of Children and Family Development and Union of BC Municipalities on the Poverty Reduction Forum held in Richmond March 2015.

Guidance Planning Strategies: Met with Colin Campbell at GPS to provide information on scholarship funds, they would like to start a fund for college students studying business to celebrate 20 years in business.

Friends of Children Fund: received notification from Friends of Children office that Cranbrook Rotary Club individual members contributed \$1150.00 to them for their opportunity fund. Once payment received fund will be ready to endow at \$10,866.80.
