COMMITTEE REPORTS

President Eburne thanked the Grants Committee and Executive Director Wilcox for the successful luncheon May 29th held in the Manual Arts Training Centre focusing on grants to local organizations and the announcement of the 2015 Sustainable Community Builder award presented to Mr. Gord Johnston by Mayor Pratt.

The format changed significantly from other years and feedback on the shortened presentation(s) has been positive.

Hanemayer Endowment Fund grants will be awarded following an independent legal interpretation of the Foundation's administration fee relating to the Hanemayer funds.

EXECUTIVE DIRECTOR

Riley Wilcox reported that a significant amount of her time during the last few weeks was spent dealing with the Ryan family donation and sale of securities flowing through to Key City Gymnastics including weekly meetings with Mr. Ryan. She is also compiling information from the Vancouver Foundation as well as researching the history of the Casey and Corinne Hanemayer family endowment fund.

NEW BUSINESS

KEY CITY GYMNASTICS

Executive Director Wilcox received and signed a letter from Mr. Al Ryan dated June 8, 2015 regarding his dissatisfaction with the length of time the Foundation took to sell securities his family was donating to Key City Gymnastics.

In his letter, Mr. Ryan threatened to start legal action against the Cranbrook and District Community Foundation and President Wayne Eburne personally.

Mr. Ryan has been into the Foundation office several times regarding the Foundation's failure to act expeditiously and he feels the Foundation should make up the \$10,000 shortfall due to the length of time it took the Foundation to sell the securities.

Former Treasurer Bev Bull suggested the Board may be facing what could become a legal matter regarding the share transfer but also, there is the matter of harassment of our employees. Bev advised that should the Board wish to secure the services of legal counsel in relation to this

matter, formal notification to our insurer of the pending action is required as we may have insurance coverage against future claims.

Bev also suggested that the Board should discuss what constitutes harassment and how best to protect our staff, even if we have a policy.

ROUND TABLE

Randal Macnair thanked the Foundation for inviting him to attend the 2015 Community Foundations of Canada Conference held in Calgary in May.

Randal also advised that there are several people actively involved in establishing a fund for the community of Fernie.

Director Murray thanked former Directors Bull and Crane for their dedication and contribution to the Cranbrook and District Community Foundation during their respective terms. Both Directors spent a considerable amount of time—it shows and well done!
